MAIN IP PARTICULARITIES



Trade Marks

- Most non-traditional trade marks cannot be registered as TMs in Brazil (you may only register visual, position, and 3D marks)
- Registration of a TM lasts approximately 12 months



Patents & Utility Models

- Patent registration takes more than 5 years
- Brazil grants a 12-month grace period prior to the filing of the application during which disclosure of the invention does not affect the novelty requirement for patentability
- "Swiss-type" claims are allowed, though limited
- Utility models are protected and are granted for a 15-year term as of the date of application



Industrial Designs

- Unregistered designs are not protected in Brazil
- The validity of this registration lasts for 10 years from the filing date, renewable for 3 consecutive 5-year periods
- Brazil has just become a contracting party to the Hague Agreement (2023)



Copyright

- Copyright for computer programs lasts for 50 years counted from the 1st of January of the year subsequent to its publication or creation
- Databases are protected through copyright
